VISA INFORMATION

A VISA IS NOT REQUIRED FOR TOURISTS WHO ARE VISITING THAILAND FOR LESS THAN 30 DAYS AND HOLD A CONFIRMED FLIGHT TICKET OUT OF THAILAND WITHIN 30 DAYS. THIS APPLIES TO TOURISTS WHO HOLD VALID PASSPORTS, WHICH COME UNDER THE VISA EXEMPTION RULE.

TOURIST VISA. THIS ALLOWS A STAY OF UP TO **60 DAYS** FROM ARRIVAL IN THAILAND AN EXTENSION OF UP TO 30 DAYS CAN BE OBTAINED ON APPLICATION TO THE IMMIGRATION AUTHORITIES AND PAYMENT OF THE CURRENT FEE. THE LENGTH OF EXTENSION IS AT THE DISCRETION OF THE AUTHORITIES AND CAN RANGE FROM 7 TO 30 DAYS.

THIS IS CLASSIFIED AS A SINGLE ENTRY AND THE TOURIST HAS TO ARRIVE IN THAILAND WITHIN **90 DAYS** OF THE DATE OF ISSUE OF THE VISA BY THE CONSULATE FOR DOUBLE ENTRY VISAS ETC THE PERIOD IS DOUBLED.

THE COST OF A SINGLE ENTRY TOURIST VISA IS £25, A DOUBLE IS £50 AND FOR A TRIPLE £75

NON-IMMIGRANT VISA. THIS IS AVAILABLE TO VISITORS TO THAILAND FOR PURPOSES OTHER THAN TOURISM. E.G. BUSINESS, TAKING UP EMPLOYMENT, ALIENS MARRIED TO THAI NATIONALS AND PEOPLE OVER THE AGE OF 50 ETC.

THE VISA ALLOWS A STAY OF UP TO **90 DAYS** FROM DATE OF ARRIVAL. **ALL APPLICANTS** MUST PROVIDE SUPPORTING DOCUMENTS I.E. LETTER FROM COMPANY, COLLEGE, EMPLOYERS ETC. STATING PURPOSE OF VISIT OR COPY OF MARRIAGE CERTIFICATE ETC PLEASE SEE ATTACHED FOR LIST OF ACCEPTABLE SUPPORTING DOCUMENTS. **TEACHERS ARE NOW REQUIRED TO SUPPLY A COPY OF THEIR POLICE CLEARANCE CERTIFICATE.**

THE COST OF SINGLE ENTRY IS £50.00.

A MULTIPLE ENTRY NON- IMMIGRANT VISA IS AVAILABLE THIS IS VALID FOR 12 MONTHS. (FROM THE DATE OF ISSUE) HOWEVER YOU MUST LEAVE THE KINGDOM EVERY 90 DAYS.

THE COST OF MULTIPLE ENTRY IS £125.00.

HOW TO APPLY

TOURIST VISA FORWARD COMPLETED AND SIGNED FORM, TOGETHER WITH TWO RECENT PHOTOGRAPHS, PASSPORT, THE CORRECT FEE, STAMPED ADDRESSED PRE PAID ENVELOPE FOR RETURN (**WE STRONGLY RECOMMEND SPECIAL DELIVERY**)
(IT IS YOUR PASSPORT!!)

NON-IMMIGRANT VISA AS FOR TOURIST BUT WITH SUPPORTING DOCUMENTATION MENTIONED.

METHOD OF PAYMENT

CASH, CHEQUES OR POSTAL ORDERS MADE PAYABLE TO "**THE ROYAL THAI CONSULATE**".

CHECK LIST

- * PASSPORT (*Must have 6 months validity on return to UK*)
- * TWO RECENT PHOTOGRAPHS (*Within the last 6 months*)
- * CORRECT FEE
- * NON IMMIGRANT VISA SUPPORTING DOCUMENTAION
- * PREPAID RETURN POSTAGE (*Special Delivery*) ON POSTAL APPLICATIONS ONLY

**A COPY OF MARRIAGE CERTIFICATE IN ENGLISH AND COPY OF SPOUSE PASSPORT OR ID CARD.
A COPY OF BIRTH CERTIFICATE IN ENGLISH (APPLICANTS CHILD)
COPY OF FAMILY MEMBERS PASSPORT AND VISA.**

OVER 50: -

**IF IN RECEIPT OF PENSION A COPY OF PENSION STATEMENT IS REQUIRED OR A BANK STATEMENT
SHOWING PENSION PAYMENT.
PROOF OF INCOME WITH A MINIMUM OF £900 PER MONTH (IF NOT IN RECEIPT OF A PENSION)**

VOLUNTEER: -

**AN OFFICIAL LETTER OF INVITATION FROM THE RELEVANT ORGANISATION/CHARITY IN ENGLISH.
COPIES OF ORGANISATION DOCUMENTS MUST BE SIGNED AND THE OFFICIAL SEAL AFFIXED.**

CATEGORY "ED" (EDUCATION/TRAINING)

**AN OFFICIAL LETTER OF ACCEPTANCE FROM THE SCHOOL/UNIVERSITY ETC IN ENGLISH CONFIRMING
PURPOSE OF VISIT.
COPIES OF COMPANY DOCUMENTS MUST BE SIGNED AND THE COMPANY SEAL AFFIXED.**

CATEGORY "B" (BUSINESS/EMPLOYMENT)

**AN OFFICIAL LETTER OF INVITATION/EMPLOYMENT FROM THE COMPANY IN ENGLISH WITH A COPY OF
CORPORATE DOCUMENTS AND A COPY OF SIGNED CONTRACT OF EMPLOYMENT.
COPIES OF COMPANY DOCUMENTS MUST BE SIGNED AND THE COMPANY SEAL AFFIXED.**

**CONSULATE OFFICERS CAN AT ANY TIME REQUEST ADDITIONAL INFORMATION AND DOCUMENTS AS
DEEMED NECESSARY.**
